- 1. The Board Meeting at 78 Twin Ridge Parkway, Round Rock, Texas was called to order at 7:01pm by the President Dale Ricklefs, a quorum was present. (Present were Directors Donna Allen, Tom Castro, Deke Kittrell, Dale Ricklefs, Justin Tanner and Lamar Urbanovsky)
- 2. Homeowner Forum: New Neighbors Aaron & Monique Travis stopped in for introductions.
- 3. President Ricklefs briefed the Board on the Street Sign Options and was directed by the Board to work with the City staff to get an appropriate logo on the signs. All options on placement of the signs have been reviewed and it has been determined they will have to be placed on poles as in other neighborhoods and 7 new poles will be required in addition to the existing poles. The City of Round Rock is requiring the installation of the new signs and will absorb the cost.
- 4. President Ricklefs raised the issue of the Annual Homeowners Meeting time and location.
